- The fund will typically invest in companies strategically aligned with trends such as climate change, resource constraints, growing populations, and ageing populations. The fund avoids investing in fossil fuels and companies that stand to be disrupted by the transition to a low-carbon economy;
- · Income distributions are generally made on a semi-annual basis;
- A management fee of 0.70% per annum of the asset value of the fund is charged. A buy/sell spread may be charged when entering or exiting the fund; and
- Online access to investment details via Portfolio Online.

Objectives, financial situation, and needs

This product has been designed for consumers who:

- Are seeking capital growth through exposure to an actively managed global equity fund;
- Are willing to pay the fund's management fee through the value of their invested capital;
- Would be comfortable to invest their capital for a minimum suggested timeframe of at least five years;
