Class of consumers that fall within this target market

The information below summarises the overall class of consumers that fall within the target market for the Net Zero Transition Resources Active ETF (Managed Fund), based on the product key attributes and the objectives, financial situation and needs that this product has been designed to meet.

Product description and key attributes

The key product attributes of the Net Zero Transition Resources Active ETF (Managed Fund) are:

- The Net Zero Transition Resources Active ETF (Managed Fund) seeks to achieve a total return after fees that exceeds the total return of the Benchmark (S&P Global Natural Resources Index (net dividends reinvested) in AUD) over rolling five year periods;
- The fund seeks to provide exposure to a diversified portfolio of global natural resource companies operating in the materials, energy, utility, agricultural, industrial and consumer staple sectors. The fund typically holds between 25-50 companies diversified by sector, market capitalisation and country;
- Income distributions are generally made on a semi-annual basis;
- A management fee of 0.85% per annum of the asset value of the fund is charged; and
- As a traded security, investors are able to enter and exit the investment anytime on the Australian Securities Exchange during trading hours.

Objectives, financial situation, and needs

This product has been designed for individuals who:

- Are seeking capital growth through exposure to an actively managed transition resources strategy;
- Are willing to pay the fund's management fee through the value of their invested capital;
- Would be comfortable to invest their capital for a minimum suggested timeframe of at least five years;
- Have a very high risk tolerance and are willing to accept the risks of losing some of their invested capital; and
- Want the flexibility of investing in an ETF.

The Net Zero Transition Resources Active ETF (Managed Fund) is likely to be consistent with the likely objectives, financial situation and needs of the class of consumers in the target market.
